There is no immediate/current impact on the financial operation or other activities of the company due to this Show Cause Cum Demand Notice. However, it is too early to ascertain the impact at this stage on the financial, operation, or other activities of the company due to this Show Cause Notice considering the long process of finalization after the representation of the company is served to the authorities.
